

ACTIVE PROJECT STATUSES


- o *Planning* Project plans are documented, the project deliverables and requirements are defined with stakeholders and reviewing agencies, and the project schedule is created.

- Design Procurement Services are being solicited for architectural/engineering services to complete design documents.
- o **Design** Project is being designed by the Architect/Engineer and going through the necessary review & approval processes.
- **Contractor Procurement** Construction services are being solicited.
- In Construction The construction work is awarded to a Contractor and preconstruction (e.g., material ordering) and/or active construction is underway.
- o <u>Substantial Completion</u> Construction work is sufficiently completed with all requisite inspections & approvals obtained for use and/or occupancy.
- Final Completion (Closeout Approval Requested) Project manager has fully accepted contract work AND punchlist/corrective work is 100% complete; any required trade permits/inspections are 100% approved; applicable operating manuals, as-builts & warranty information are on hand; and, final payment is approved.
