

Hello Timekeepers,

Please share these items as appropriate with your time approvers and employees.

- 1. If employees are putting in leave requests in Oracle for September and onward, please ask them to either hold off or to enter it in one day increments. Certain calendars still need to be updated in Oracle which may cause leave to overstate hours if entered in more than one day increments.
- 2. Sick and Safe leave accrual amounts are currently not yet updated. They will be updated by the first 10 month employee pay period.
- 3. The workday bulletin is attached again. This is the final version and is the one also posted on the website.
- 4. If you see Regular Salary Time or Regular Wages Time on an employee timecard, please do not change those hours or any data on that line of the timecard. This type of pay is system generated and should never be changed. If you have to pay an employee for something other than their normal job, please add a line and enter the appropriate hours type(ex, Time Entry Wages or Summer Incentive).
- 5. Summer Incentive hours type requires that an SI program be added. If the SI program is not added costing will be incorrect and your timecard may be put into error status. Error status means the employee would not be paid.
- 4. It is once again Payroll Roster time. Please check your rosters to ensure any terminated(resigned, retired) employees or transferred employees are no longer listed. Please ensure all of your new staff are showing correctly in your roster.
